

PRIVACY POLICY OF THE ARTEXT SYSTEM WEBSITE

1. OBJECT

The owner of this website gives users this document to comply with the obligations set forth in Spanish Law 15/1999 on Personal Data Protection (LOPD) and its draft legislation. This document is permanently available on the <https://sistema-artext.com/> website, so that users can consult it, file it, or print it. Anyone who accesses this website will be considered a user and commits to strict compliance with the terms of this document, and to any other legal regulation which may be applied.

2. INFORMATION ON THE AUTOMATED PROCESSING OF THE USER'S PERSONAL DATA

The arText system website does NOT collect personal data introduced by the user in any type of form. To access the <https://sistema-artext.com/> website, you do NOT need to provide any personal data. Therefore, we expressly ensure that the user's personal data are not disclosed under any circumstances to third parties.

4. USE OF COOKIES

The arText system website uses cookies to obtain information and perform statistical analyses on the use of the <https://sistema-artext.com/> website. Cookies are anonymous and do not refer to the user's personal data, nor in any case can third parties access the data the user may have on their personal computer system.

Likewise, we guarantee that the texts written by the user in the online editor of the arText system are NOT saved on our server in any case nor under any circumstance. The user themselves must save a local copy (on their computer, hard drive, pen drive, etc.) of the texts written in the arText system editor if they wish to have them at their disposal at a later date.

5. IP ADDRESSES

The <https://sistema-artext.com/> website servers will be able to automatically detect the IP address and domain name used by the user. An IP address is a number automatically assigned to a computer when it connects to the Internet. This information can be registered in an activity file in the server that allows subsequent data processing in order to obtain statistical measurements detailing the number of page impressions, the number of visits to web services, the order of visits, the point of access, etc.

6. SECURITY

The arText system website ensures the absolute confidentiality and privacy of the texts written in its online editor and has adopted the organizational and technical measures required to ensure the security and integrity of the data processed.

7. SENDING UNSOLICITED EMAIL (SPAM)

We are absolutely against spamming, and we never perform this type of activity from the arText system website.
